Submission of Application Forms under MMNMA and MMNBA, 2026-27

All eligible UG and PG students are informed that application-form distribution under the **Mukhya Mantrir Nijut Moina Aasoni (MMNMA)** and the **Mukhya Mantrir Nijut Babu Aasoni (MMNBA)** has commenced for 2026-27. MMNMA is for eligible female students, and MMNBA is for eligible male students.

Important Dates

- Distribution of application forms: From 6 August 2026 to 11 August 2026
- Submission of the completed application form and documents to the College: 12 August 2026 to 14 August 2026

UG and PG students must submit the hard copy of the duly filled and signed application form with the required documents.

Mandatory Requirements

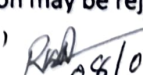
- The applicant must be a permanent resident of Assam and possess a valid Aadhaar number.
- An Aadhaar-seeded bank account enabled for the Aadhaar-Based Payment System (ABPS).
- Matching name and particulars in the Aadhaar card, bank account, application form and College records.

Documents to be Submitted

- Duly filled and signed hard copy of the application form.
- Photocopy of the Aadhaar card.
- Photocopy of the Aadhaar-seeded bank passbook.
- Admission receipt or proof of current admission.
- Prescribed Student Undertaking/Declaration and Aadhaar consent, signed as required by the student and parent/guardian.
- Other documents applicable under the respective scheme.

Additional eligibility: MMNBA is limited to regular male students of UG 1st/2nd Year and PG 1st/2nd Year admitted under the Fee Waiver Scheme, with family income below Rs. 4.00 lakh. UG applicants under either scheme must be unmarried and must not opt for the Dr. Banikanta Kakati Merit Award/Scooter Scheme; these restrictions do not apply to PG. PG students receiving the Chief Minister's Jibon Prerana Scheme benefit are ineligible. Students not enrolled for the previous final examination are ineligible; continuing beneficiaries require at least 70% attendance. MMNBA applicants must submit Fee Waiver proof and a valid income certificate or parent's ration card.

Important: Students must verify their Aadhaar number, bank account number and IFSC code before submission. Incomplete applications or applications containing incorrect information may be rejected.
